Oregon Adventures Sweepstakes Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. THERE IS NO CASH VALUE ON THE PRIZES. PARTICIPANTS MUST BE 21 OR OLDER TO ENTER.

1. **Eligibility:** This Campaign is open only to those who sign up at <https://winberryfarms.com> and who are 21 years of age or older as of the date of entry. The Campaign is only open to legal residents of Oregon and is void where prohibited by law. Employees of Herban Industries OR LLC, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
